OFFICIAL 2020 Vision Repeating Raffle – RULES / POLICIES / GUIDELINES

Purchase of a Raffle Ticket constitutes you have read, understand, and agree to comply with these Rules, Policies and Guidelines. Void where prohibited elsewhere by law. Prize package is transferable.

We all know “hindsight is 2020.” But with year “2020,” . . . its ahead of us now. In our future !

The “2020 Vision” Repeating Raffle” is jointly sponsored by and benefiting the nonprofits Massachusetts Motorcyclists Survivor's Fund, Inc.; the Southeastern Massachusetts Motorcyclists Survivor's Fund, Inc., and American Citizen Biker Political Action Committee, an independent expenditure committee, (hereinafter “Beneficiaries”) for their stated missions, including but not limited to Massachusetts “Riders Helping Riders / Bikers Helping Bikers,” in need due to accidents and injuries; to promote motorcycle awareness aimed to reduce accidents and injuries; and to inform and educate others on and of issues pertaining to and concerning the American motorcyclists community nationwide. This monthly Raffle is being conducted under License / Permit, No. 2019-002, issued March 12, 2019, by the City of Amesbury, Massachusetts, for up to twelve (12) raffles 2019-2020, and is conducted in conjunction with rules and regulations of the Massachusetts State Lottery Commission. Paul W. Cote, on behalf of all three (3) Beneficiaries will have full authority on all drawing events as well as audit/awarding of prizes. Any unresolved dispute will be resolved via Arbitration, in Essex County, Massachusetts.

There will be **ONE (1) WINNER EACH MONTH**, who will **PICK ONE (1)** of the prize packages offered. Prizes for each monthly Winner to **SELECT ONE (1)** from will include an option of trips, food packages, firearms, clothing, and/or cash, or other items beneficiaries select and promote for that monthly drawing.

(1) Only **Two Thousand Twenty (2020)** raffle tickets each monthly raffle will be available for sale. Each monthly raffle will offer “Winner's Choice” of One (1) prize package which will have a total value of Two Thousand Twenty Dollars (\$2,020.00), with one (1) major designated prize item and additional items to a total equal to Two Thousand Twenty Dollars (\$2,020.00) to one (1) monthly winner. Any additional costs of transferring the prize to the winner, via our local dealers, manufacturers, and/or suppliers, and the monthly winner's local dealer, will be included and any cash equivalent will be added, to total each monthly prize package, \$2,020.00.

(2) This is a 'repeating raffle,' with drawing to occur on the 20th of each month (e.g., May 20, June 20, July 20, August 20, etc.). Upon the conclusion of each monthly drawing and a winner declared, contacted and prize transferred, all other raffle tickets sold are void for that month's drawing.

- (3) Beneficiaries will not sell or give your private information provided on raffle tickets or other documentation relative to this raffle to any other Party, unless required by law or valid Court Order.
- (4) The purchase of **\$20.20** per raffle ticket is required for participation and is considered a donation to the Beneficiaries . All donations must be paid in full prior to the drawing in order to be included in the raffle. All raffle ticket sales are final and are non-refundable.
- (5) Ticket purchases are available to those eighteen (18) years or older.
- (6) Raffle tickets are available from any Beneficiary and other designated co-supporters, in person and/or via their web sites and Paypal. Neither Facebook nor Paypal are sponsors of these Raffles. Participants purchasing raffle tickets via the web sites will receive an automated receipt from Paypal AND then will be e-mailed the next 'running number(s)' (from 0001 through 2,020) available, by the Beneficiaries. No purchasers tickets stubs will be mailed.
- (7) Each raffle ticket purchased will qualify as one entry into the current monthly raffle drawing only. The next repeating monthly raffle will begin at 12:01 a.m., the 21st of each month. All prior monthly entries are void after the winning donor is contacted, accepts or transfers the prize.
- (8) Should the winner reject the prize, rejection must be provided to the Beneficiaries in writing, at which time, another drawing will be announced via their websites and on Facebook event pages accordingly and all remaining entries from that monthly raffle ticket sales remain active and eligible.
- (9) A minimum of five hundred and five (505) tickets must be sold by 2:02 p.m., Eastern Standard Time, (EST) of the 20th of each month, for that monthly's drawing to occur. If less than 505 are sold for that month, the drawing is canceled for that month and all tickets sold are carried over into the next month's drawing, with the count to the total of two thousand twenty (2,020) available adjusted accordingly. If 2,020 tickets are sold before 2:02 p.m. (EST) of any month, no further ticket sales for that period will be sold and the drawing will be conducted, as scheduled, on the 20th of that month.
- (10) Prizes, are 'Winner's Choice' of one (1) prize advertised. Prizes available for “winner's choice” are picked by the Beneficiaries. No substitutions.
- (11) The first raffle drawing date will be **May 20th, 2019**, and will be announced on the Beneficiaries websites as well as Facebook pages. Neither Facebook nor Paypal are sponsors of these Raffles.
- (12) Raffle tickets will be drawn the 20th of each month at 7:00 p.m. (EST) at a public location, announced one (1) week in advance, and 'recorded live,' saved and posted on the Beneficiaries web pages and Facebook event pages within twenty four (24) hours. Raffle participants and the general public are welcomed to attend and witness the drawing(s) at their own expense.
- (13) Participants agree in advance to allow Beneficiaries to list, at a minimum, their first name and last name initial (e.g. Paul C.) and their city / town and State of Residency (e.g. of Amesbury, MA) on their web sites and Facebook pages and other promotional materials and agree to be available for public relations media (photographs, interviews) needs when the prizes are picked up and/or redeemed and used, for no compensation.

(14) At least one prize each month will be a firearm. By purchasing a raffle ticket, participant(s) attest that they are a law abiding citizen of good moral character, may legally possess any firearm won, have intention of using the firearm only in a safe and legal manner, and will or have already obtained instruction on the safe use and operation of any firearm won. Gift raffle tickets may be purchase by another who may not have on-line access, and the gift recipient's name will be entered, as requested by the Purchaser. The Winner's Choice prize package IS TRANSFERABLE by the winner to another person, via a written designation and request to transfer prize, and who also agrees to all these rules upon acceptance of the transfer.

(15) Notification attempts will begin immediately after the drawing, and arrangements for the transfer of any prize will begin upon confirmation of winner.

(16) Three (3) attempts will be made to notify the winner based on the information provided by the participant, (via either telephone, Facebook, email and/or USPS). It is the sole responsibility of the participant to notify the Beneficiaries of any change in mailing address, email address and/or phone number.

(17) Winning participant need not be present to win. All prizes must be claimed within thirty (30) days of the drawing date by notifying vendor. Any prize not claimed within thirty (30) days of the drawing date will become the property of the Beneficiaries, and a 2nd drawing will take place with notice given on the Beneficiaries websites as well as Facebook pages. Neither Facebook nor Paypal are sponsors of these Raffles.

(18) Winners must pick one (1) of the prizes as listed and promoted. Depending on winner's location and local laws, the prize package chosen by the Winner may be picked up in Amesbury, Massachusetts, or, may be mailed, or pick-up arranged with a local dealer where it will be shipped and stored for winner's redemption. Please allow ample time for delivery (estimated at less than 10 days). Any and all shipping fees/destination charges are included in the \$2,020.00 prize value package, not in addition to, and will be accounted for in writing to the winner.

(19) The raffle ticket winner must provide proof of identification, must be eighteen (18) years of age or older for any firearms, twenty one (21) years of age or older for handguns, a US resident, and must be capable of passing all applicable background checks.

(20) Any raffle winner who does not meet Federal, State, local or other legal requirements to purchase, own or possess the awarded prize, or is unable to pass the applicable background check where firearm(s) are chosen, should advise the beneficiaries and/or designate and person who meets the above. That person will be still be listed as the month's "winner."

(21) Firearms are not transferable. The participant designated by the winning raffle ticket must claim the firearm. No straw purchases allowed.

(22) The Beneficiaries reserve the right to make substitutions depending on availability or discontinuance of firearms or ammo or other related prizes. Any substitutions that have to be made will be replaced by a prize of equal or greater value.

(23) Any taxes on cash prizes of two thousand twenty dollars (\$2,020.00) value are not included in the prize package and are the sole responsibility of winners. A “1099” form will be provided to the winner as required by January 31st of the year after the prize has been won.

(24) At no time will the Beneficiaries take possession of any of any vehicle or firearms involved in this raffle. All firearm transfers must be done through Federal Firearms Licensed (FFL) dealer(s) only, and all applicable Federal, State and local laws will apply.

(25) In all drawings, where the event winner chooses a firearm prize, such prize winner needs to pick up the firearm at State-Line Firearms and Ammo, in Plaistow, New Hampshire, or, have the awarded firearm(s) transferred from them to their local FFL dealer. Shipping and any other additional costs involved with the transfer ARE and WILL BE included in the \$2,020.00 prize value. The Beneficiaries, with its FFL dealer will coordinate with the winner and their local designated FFL dealer. The Participants agree in advance if they are the winner to cooperate with the Beneficiaries and their designated FFL to make arrangements with their local FFL dealer for transfer of the prizes, within twenty (20) days of the drawing.

(26) The Beneficiaries and co-supporters and its FFL dealer and the winner's local FFL dealer make no warranties regarding any firearms and no representations regarding suitability of purpose for any firearm. Winners are to deal directly with the manufacturer or local FFL dealer in the event of problems.

(27) The liability of the beneficiaries and its Officers, Directors and Members is limited to the purchase price of the raffle ticket purchased.

(28) Raffle is void where prohibited.

(29) Please have all questions answered before purchasing a “2020 Repeating Raffle” Ticket.
